#### At the same time, I commit myself to:

- 1) fulfill all duties, laid on me by the legal act of 20<sup>th</sup> July 2018: Law on Higher Education and Science (Journal of Laws from 2018, item 1668, with later amendments) and Studies regulations;
- 2) inform the Dean of the Faculty, within maximum 7 days, about all changes concerning my personal data, in particular concerning my marital status, surname, address of residence, correspondence address, e-mail address and identify document; in a situation of not complying with this duty I will face all the negative consequences in this respect;
- 3) regular payment of the fees for educational services related to the above mentioned studies in the amount determined in the internal directive concerning the amounts of fees, to the following bank account indicated by the University:

#### I acknowledge that:

- 1) payment for the educational services listed in the internal directive concerning the amounts of fees is established for the full cycle of studies and until completion of studies by persons enrolled for studies for a given academic year; the University may not increase the amounts of the established fees nor introduce new fees; the above does not concern the increase of fees for classes which are not a part of the programme of studies not the fees for accommodation in dormitory or for food at the student canteen, with one provision, namely: in case of transfer to another university, change of faculty, change of field or mode of study, repetition of a semester, leave from classes, return from a leave of classes or resumption of studies the amount of fees defined for a full cycle of study for students taking up studies in the given academic year within this semester of studies for which the student has been enrolled is in force;
- 2) the fees for educational services and for documents related to pursuing of studies are to be paid to the indicated bank account; a change of the bank account does not require the change of the declaration and the University shall inform the student immediately about a change of the bank account;
- 3) the date when the fee reaches the University's account is assumed the date when the fee has been paid;
- 4) each delay in fee for educational services payment or payment of incomplete amount may result in the University's calculating statutory interest for delay;
- 5) the University is not responsible for the consequences of incorrect acknowledgement of the fee which is the result of circumstances on the part of the person who pays the fee, specifically being the result of providing incorrect bank account or other similar reasons;
- 6) the University may strike the student off the register of students due to not having paid the fees related to pursuing of studies; simultaneously legal debt collection proceedings against the student may be initiated;
- 7) I may apply for a full or partial fee for educational services fee waiver or payment in installments on terms defined in the internal directive concerning the amounts of fees;
- 8) I can apply for a full tuition fee refund, on my request, on a provision of submission of a written withdrawal from studies before they begin.

*I* hereby confirm having familiarized myself and accepted the legal acts which are in force at the University defining the terms of tuition fees collection and the amounts of fees and I oblige to obey them.
