Regulations of the photo contest „Wrocław through the lenses of multicultural students – SHOT! 2022”

**Art. 1**

**General provisions**

1. These Regulations determine the rules of the organization of the photo contest “Wrocław w obiektywie studentów wielu kultur – SHOT! 2022”, hereinafter referred to as Contest.
2. The official English version of the name of the Contest is “Wrocław through the lenses of multicultural students – SHOT! 2022”.
3. The Contest is organized by Wrocław University of Science and Technology – International Relations Office, based in Wrocław, 12 Na Grobli St., 50-421, hereinafter referred to as the Organizer.
4. The Contest and the exhibition of submitted photographs is organized as part of the project “Międzynarodowe Centrum Politechniki Wrocławskiej – Uczelnia otwarta na nowe kultury” (“The International Centre of Wrocław University of Science and Technology – University Open to New Cultures”), hereinafter referred to as the Project. The Project is financed by the Narodowa Agencja Wymiany Akademickiej (Polish National Agency for Academic Exchange) within the “Welcome to Poland (2020)” programme.
5. The regulations of the Contest, hereinafter referred to as Regulations, are published on the Organizer’s website (<https://dwm.pwr.edu.pl/>).
6. The Contest is conducted on the territory of the Republic of Poland.

## **Art. 2**

### **Contest Objectives**

The objective of the Contest is:

- 1) to present the city of Wrocław in photographs with authors' comments, in the form of an exhibition,
- 2) to identify Wrocław University of Science and Technology ambassadors among the participants,
- 3) to support the process of forming in the recipients the attitude of openness, tolerance, and the awareness of the presence of international students representing different cultures in Wrocław.

## **Art. 3**

### **Contest Subject**

1. The subject of the Contest is a photograph with author's comment, hereinafter referred to as Entry.
2. The topic of the Entry is "Wrocław through the lenses of multicultural students". The task of the participant of the Contest is to present the topic of the Entry through his/her eyes, using original framing of various sites in the city, seen through the angle of their own culture, sensitivity, and sense of aesthetics.

## **Art. 4**

### **Participation conditions**

1. In order to take part in the Contest, the participant, hereinafter referred to as the Participant, must:
  - 1) be adult on the day of submitting his/her Entries,
  - 2) not have Polish citizenship,
  - 3) be a:
    - a) student of full degree course,
    - b) PhD student,
    - c) participant of mobility programmes such as Erasmus+,  
in the summer semester of the academic year 2021/2022.
2. The Contest is open, free, and voluntary.

3. Due to the requirements of the Polish National Agency for Academic Exchange (NAWA), Russian citizens are excluded from the Contest.
4. Submitting an Entry is equivalent with the approval to present it at the exhibition referred to in art. 7 paragraph 8.
5. One Participant may receive no more than one Jury prize and audience award.

**Art. 5**

**Submission of the Entries**

1. In order to take part in the Contest, the Participant fills in an e-form placed on the website: <https://wroclaw.tech/SHOT2022-form>.
2. To be qualified for the Contest, an Entry must contain:
  - a) personal and contact information,
  - b) photographs taken by the Participant (up to the number specified in paragraph 5), presenting a site in Wrocław, which meets the requirements provided for in paragraph 4,
  - c) title of the photo (a maximum of two words) and author's comment (a maximum of 800 words including spaces),
  - d) a photo of oneself (self-portrait),
  - e) a short biography of the author,
  - f) acceptance of the Regulations,
  - g) consent to process personal data,
  - h) acceptance of the Participant's declaration/Licence, constituting Annex 1 to these Regulations.
3. Upon submitting the Entry, the Participant becomes also a participant of the Project specified in article 1 paragraph 4 and is thus obliged to submit scans of documents required by the Narodowa Agencja Wymiany Akademickiej (Polish National Agency for Academic Exchange):
  - a) admission form,
  - b) declaration of the Project's participant,
  - c) additional consent to process personal data.

The aforementioned documents should be submitted using the e-form specified in paragraph 1.

4. The photographs must meet the following requirements:
  - a) they should not be blurred, unless this is part of an intentional artistic effect,
  - b) resolution: 200-300 PPI,
  - c) file size: 7 MB minimum,
  - d) file format: jpg, tiff or png,
  - e) filename format: author's-last-name\_title.
5. Participant may submit a maximum of 5 (five) Entries.
6. Should the Participant submit more Entries than provided for in paragraph 5, the Organizer will call the Participant to indicate the number of Entries that meet the requirements within 3 days upon being informed by e-mail. If the Participant does not fulfil this obligation, the Organizer will inform the Participant that his/her Entries will be regarded as not meeting the Regulations and will not take part in the Contest.
7. Entries that infringe the law or common decency, in particular inciting hatred based on religion or ethnicity, will not take part in the Contest.
8. The deadline for submitting the Entries is specified in article 8 of the Regulations.

**Art. 6**  
**The Jury**

1. The Entries will be assessed by the Contest jury, hereinafter referred to as the Jury, which will be composed of:
  - a) representative of the authorities of Wrocław University of Science and Technology,
  - b) representative of the Organizer,
  - c) representative of the Information and Promotion Office of Wrocław University of Science and Technology,
  - d) representative of the Students' Union of Wrocław University of Science and Technology,
  - e) two representatives of international students of the Wrocław University of Science and Technology.
2. The Jury will be presented with Entries that are verified to meet the requirements provided for in article 5 of the Regulations.

3. The Entries will be assessed basing on the fulfilment of the Contest's objectives, as well as their quality and attractiveness.
4. The Jury meeting will be held at a place and time determined by the Organizer and will be closed to the public. The meeting may also be held remotely using electronic communication mechanisms.
5. Jury decisions are final and binding for all Participants. Participants cannot appeal against the decisions. Jury opinions on the Entries are not public.

**Art. 7**  
**Results and prizes**

1. From among the Entries, the Jury will choose winners of the 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place, hereinafter referred to as Laureates, and grant up to 3 distinctions.
2. Results of the Contest will be announced on the Organizer's website at the date indicated in article 8 of the Regulations. Additionally, the Laureates will be informed about the results via e-mail.
3. The Jury will present the Laureates with in-kind prizes in the form of: a OnePlus Nord smartphone worth ca. 1900 PLN (1<sup>st</sup> place), a Polaroid instant camera with films worth ca. 800 PLN (2<sup>nd</sup> place) and a wireless speaker worth ca. 400 PLN (3<sup>rd</sup> place). Authors of the distinguished Entries will obtain hoodies and gadgets with the Wrocław University of Science and Technology logo.
4. The Jury may decide to divide the prizes in a different way than specified in paragraph 3, award additional prizes, or not to award a given prize.
5. Additionally, an Audience Award will be granted basing on an open voting on an Internet platform determined by the Organizer, announced on its website on 11 May 2022. The rules for granting this award will be available at that platform. Author of the Entry with the highest number of votes will obtain upmarket headphones worth ca. 370 PLN, as well as a hoodie and gadgets with the Wrocław University of Science and Technology logo.
6. The Organizer will determine the form of delivering the prizes after the Laureates have been announced.

7. The Organizer shall not be held responsible for not delivering the prize as a result of providing an incorrect address by the Participant.
8. The highest ranked Entries, including the awarded and distinguished ones, will be presented at an exhibition organized in Wrocław and then moved onto the Wrocław University of Science and Technology campus. For the purpose of this exhibition, the photo of the author and the short biography, submitted in the Entry, will be used. Additionally, the remaining photos that meet the requirements of the Contest will be collectively presented at the exhibition on a separate stand.
9. All Entries that meet the Regulations will be presented on the Organizer's website and profiles in social media.

**Article 8  
Schedule**

1. Start of submitting Entries – 19 April 2022
2. Deadline for submitting Entries – 9 May 2022, 11:59 PM
3. Voting for the Audience Award – 11-18 May 2022
4. Announcement of the results – 18 May 2022

**Article 9  
Copyrights**

1. On submitting his/her Entry, the Participant:
  - a) declares that he/she is the sole author of the photographs and the comments within the meaning of the Copyright and Neighbouring Rights Act, he/she has full copyright to the photograph and the comment and that they are not encumbered with any third party's rights or claims.
  - b) declares that the photographs and the comments do not infringe any third party's rights or personal interest, including persons represented on the photograph, and that he/she has obtained any consents required by the law to disseminate the photographs within the Contest and the licence provided for in section 2.

2. The Participant grants the Organizer a royalty-free, non-exclusive, unlimited in time and place, non-terminable licence (with the right to grant further sub-licences) for the use of the photographs and the comments, including photographs and comments disseminated for the first time, for the needs of the promotion and information about the Contest, on all fields of use known on the day of submitting the Entry, in particular:
  - a) In the fields of recording and multiplication – production using various techniques regardless of storage format and media, size, form, technique, covering, way and manner of distribution or making public, entering into computer memory, temporary and permanent recording, as well as making copies and filing of such recordings,
  - b) In fields other than listed above – granting public access in a way such that everyone can access them in place and time at any time, on the Internet (including websites, social media, multimedia and computer web services),
  - c) Use in Organizer's materials, including: promotional and informational materials relating to the Contest, including compilations, files, collective works and conjunctions with other rights or works, including the exercise of derivative copyright.
3. The Entries submitted in the Contest will be used in particular on the Organizer's website, official profiles on social media, in multimedia presentations, as well as exhibitions and publications organized as part of this project. The Organizer reserves the right to publish the Entries also on other websites and social media profiles.
4. The use of the photographs in accordance with the aforementioned licence shall be performed ensuring respect for the Participant's moral rights.
5. Should any of the Participant's declarations contained herein occur false, the Organizer will be entitled to exclude the Participant from the Contest and take back his/her prize.
6. Should a legal claim against the Organizer be filed by any third party in conjunction with the infringement of copyrights or personal rights as a result of the use of the photographs and comments submitted within the Contest in accordance with these Regulations, the Participant shall commit himself/herself to absolve the Organizer from any responsibility, in particular to satisfy any compensation and damages agreed in a settlement or awarded by a court of law, as well as to pay any court fees and costs of legal representation.



## **Article 10**

### **Personal data**

1. Personal data of the Participants will be processed in accordance with the provisions of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as GDPR).
2. On partaking in the Contest, each Participant agrees to process his/her personal data to the extent and for the purpose necessary to carry out the Contest with his participation (in conjunction with art. 6 paragraph 1a of GDPR). The consent is voluntary but necessary to take part in the Contest. If the Entry is used by the Organizer, the processing will not be based on the consent but the necessity to use the personal data in conjunction with the granted licence (pursuant to article 6 paragraph 1b, 1c and 1f of GDPR).
3. The personal data controller is Wrocław University of Science and Technology, 27 Wybrzeże Wyspiańskiego Street, 50-370 Wrocław, Poland. The controller can be contacted via contact form on the website <https://pwr.edu.pl/kontakt>. The controller has appointed a Data Protection Supervisor who can be contacted by e-mail at: [iod@pwr.edu.pl](mailto:iod@pwr.edu.pl). The controller makes all reasonable efforts to ensure adequate means of physical, technical, and organizational protection of personal data to prevent it from accidental or purposeful damage, accidental loss, change, unauthorized disclosure, use or access, in accordance with the applicable law.
4. Personal data of the Participants will be processed to the extent and for the purpose necessary to carry out the Contest, award the prizes, draw up the list of laureates and announce it on the Organizer's website and in social media, present the Entries at exhibitions, as well as to the extent necessary for the Organizer to exercise its licence granted by the Participant.
5. The Entries with identification data of their authors will be published in social media profiles of the Organizers. Hence, the author shall delete any metadata of the photo files that he/she doesn't want to made public.
6. The Organizer will collect the following data:

- a) for the purpose of carrying out Contest procedures (applies to all Participants): name, surname, contact address, contact data (phone number, e-mail address at the Wrocław University of Science and Technology domain),
  - b) to present at the exhibition (applies to all Participants): name, surname, photo of the author,
  - c) to identify the licensor – Participant: name, surname, e-mail address at the Wrocław University of Science and Technology domain and at a different domain, address, PESEL or type and number of identity document,
  - d) to fulfil legal duties relating to awarding the prizes (applies to Laureates): address, e-mail address in the Wrocław University of Science and Technology domain.
7. The personal data of Participants may be made available to recipients related to the Contest and its subject, i.e. to the providers of data storing services used by the Organizer. Also, personal data restricted to: name, surname, country of origin, photograph of the author and the short biography may be presented at the exhibition. The personal data may also be made available to other recipients should such obligation ensue from legal regulations.
  8. The submitted personal data are collected and processed using services provided by entities from third countries (outside of European Union). They will be transferred to the United States of America (USA) and may be processed by other entities co-operating with the service provider Google Workspace, which Wrocław University of Science and Technology utilizes regarding them as safe and necessary for its educational purposes.
  9. Information concerning the Contest will be published on the Organizer's website, which collects the data of visitors in the form of cookies files resulting from the use of the OptiCMS system and Google Analytics services.
  10. Personal data of the Participants will be stored for a period necessary to achieve the aforementioned objectives, and then for a period and to an extent required by the law. The data submitted via the form will be processed for the duration of the Contest and then for a retention period of a maximum of 18 months by the Google Forms service provider. After that date, the personal data will be used in accordance with the granted licence for a period specified by regulations related to accounting, archiving of contracts at public institutions, and pursuing civil and copyright claims.
  11. In terms of personal data processing, the Participants (with respect to the appropriate legal basis of processing) are entitled to: access their data, correct it, delete it, restrict

its processing, move it, and withdraw their consent to process it at any time, without effects on the legality of the processing prior to the withdrawal. These rights are not absolute according to the Wrocław University of Technology Privacy Policy (<https://pwr.edu.pl/en/privacy-policy>).

To exercise this right, the Participants should contact the Organizer on the e-mail address: [events@pwr.edu.pl](mailto:events@pwr.edu.pl). The Organizer reserves the right to verify the identity of the Participant in such case.

12. Should the Participant find that his/her personal data is processed contrary to the GDPR, he/she may also file a complaint to the Prezes Urzędu Ochrony Danych Osobowych (President of the Personal Data Protection Office).
13. The Organizer states that the personal data of the Participants will not be processed in an automated way and the Participants will not undergo profiling.

**Article 11**  
**Final provisions**

1. Accepting the provisions of these Regulations is necessary to take part in the Contest.
2. Any amendments to these Regulations will be published on the Organizer's website. The amendments become binding on the day of publication. However, the Participant may withdraw from the Contest in a period of 3 days from the announcement of the amendments to these Regulations.
3. In matters not covered herein, decisions shall be made by the Organizer.
4. These Regulations have been drawn up in Polish and English. In case of discrepancies between the two versions, Polish version shall prevail.
5. For matters not regulated herein, Polish law shall be applicable.
